MEMORANDUM DECISION AND ORDER GRANTING RENEWED APPLICATION FOR WAIVER OF THE CHAPTER 7 FILING FEE

The debtor has filed a renewed application for waiver of the chapter 7 filing fee (Docket Entry ("DE") No. 43), together with a letter addressed to the court describing the change in circumstances that prompted the debtor to file the renewed application (DE No. 44). For reasons explained in more detail below, the court will grant the debtor's renewed application for waiver of the chapter 7 filing fee.¹

The debtor filed an application for waiver of the chapter 7 filing fee upon the commencement of this case (DE No. 5). The court then issued an order directing the debtor to supplement the application with additional information (DE No. 20), and the debtor responded by filing an amended application (De No. 27). The court held a hearing to address the amended application and ultimately denied the application without prejudice to the filing of a renewed application in the event the debtor's circumstances changed (DE No. 35).

Pursuant to 28 U.S.C. § 1930 as amended by § 418 of the Bankruptcy Abuse Prevention & Consumer Protection Act of 2005, Pub. L. 109-8 (effective October 17, 2005), this court

may waive the filing fee in a case under chapter 7 of title 11 for an individual if the court determines that such individual has income less than 150 percent of the income official poverty line . . . applicable to a family of the size involved and is unable to pay that fee in installments.

28 U.S.C. § 1930(f)(1).

The debtor's application reflects that he is from a household of one and that he has a combined monthly income of \$985.00, or \$11,820.00 per annum. This figure is less than 150% of the applicable poverty guideline figure maintained by the Department of Health and Human Services for a one-person household living in the District of Columbia. Thus, the debtor has satisfied the first requirement for waiver under 28 U.S.C. § 1930.

² Section 1930(f) specifies that the "official poverty line" figures used for purposes of the chapter 7 fee waiver refer to those "defined by the Office of Management and Budget ["OMB"], and revised annually in accordance with [§] 673(2) of the Omnibus Reconciliation Act of 1981" The Judicial Conference of the United States interprets this language to refer to the poverty guidelines maintained annually by the U.S. Department of Health and Human Services ("HHS") because the OMB has never issued poverty guidelines or thresholds. Under the 2009 HHS guidelines, the poverty line for a one-person family living in the District of Columbia is \$10,830.00 per year, making 150% of the applicable poverty line \$16,245.00. The debtor's stated income does not exceed this threshold.

To qualify for waiver of the filing fee, the debtor must also demonstrate that he is unable to pay the fee in installments. According to the debtor's application, the debtor has monthly expenses of \$985.00, leaving the debtor without any monthly disposable income from which to pay the filing fee in installments. It is thus

ORDERED that the debtor's renewed application for waiver of the chapter 7 filing fee (DE No. 43) is GRANTED.
